Teaching

At Queens College

Sociological Analysis

Fall 2016-Present

This STEM and Writing Intensive course introduces students to the social science assumptions and methods. Students learn that sociological analysis and interpretation resembles but also differs from analysis and interpretation in other disciplines. The writing component consists of drafting and revising an annotated bibliography and a literature review.

Social Research Methods

Fall 2012 – Present, Spring 2010 – Fall 2012, 2006 – 2009

This course introduces students to the principles of social science research. Topics include examining the relationship between theory and research, the logic of research design, data collection and data analysis methods, and the presentation of findings. Assignments allow students to practice the skills required in specific research methodologies.

Modern Urban Communities

Fall 2012 – Present, Spring 2010 – Fall 2012, Fall 2009, 2006 – 2009

This course examines the social geography of the modern city and urban environment with a focus on city spaces and urban lifestyle and culture, and how they are influenced by the development of neighborhoods, residential distribution, and regional change. Topics include: colonial beginnings, the industrial city, the impact of immigration & migration on cities, changes in urban social & spatial structures, suburbanization, urban decline & economic restructuring, and the rise of entrepreneurial cities.

Sociology of Developing Countries

Fall 2009

This course examines the political economy of developing countries. After exploring the theoretical approaches that have informed the study of development and analyzing development models, students critique current approaches to solving domestic instability and poverty in these countries.

Sociology of Religion

Fall 2009

The purpose of this course is to develop an understanding of the mutually influencing interactions between a religion and its social context. To gain this insight, students analyze religious beliefs, practices, and organizations from a sociological perspective, focusing on religion in contemporary American society.

Urban Tourism: The Arts and Urban Development

2006 – 2009

The goal of this undergraduate course is to provide an understanding of the role of urban tourism in urban development, city culture, and the arts sector. Topics include the history of culture-led development, economic restructuring, the nature of urban culture, types of urban tourism projects, and the role of key stakeholders in these projects.

At Milano, the New School for Management & Urban Policy

Political Economy of the City (Graduate Course)

Summer 2009

This graduate course introduces the framework of urban policy and development in the United States. The focus is on conveying an understanding of the structure and context in which city governments, local communities, and the private sector interact to formulate and implement urban policy. Through in-class analysis and research assignments, students study the political and economic dynamics of recent major development projects in New York City.

Analysis for Decision Making (Graduate Course)

Fall 2006

The goal of this graduate course is develop the policy analysis skills of students. Through analyzing case studies and completing a course project, students are required to define and critically analyze policy issues and problems, articulate relevant decision-making criteria for policy analysis, evaluate alternative policy solutions, and assess the means and costs of implementation.

Urban Tourism: The Arts and Urban Development (Graduate Course)

Summer 2006

The goal of this graduate course was to provide an understanding of the role of urban tourism in urban development, city culture, and the arts sector. Topics included the history of culture-led development, economic restructuring, the nature of urban culture, types of urban tourism projects, and the role of key stakeholders in these projects.

At Parsons, the New School for Design

Cities, Culture, and Entertainment: Exploring New York and Other Worlds

Fall 2002, Spring 2003

This course provided students with an understanding of the dynamics associated with developing cultural and entertainment districts as urban regeneration projects. Topics included the nature of urban culture, issues of competition among cities, networks involved in urban economic development projects, and the increasing interest in cultural tourism.

At George Mason University

Imagining the Future: Literature and Context

Spring 1998

The goal of this course was to introduce students to analyzing the culture of cities through examining the political, economic, and social structures described in science fiction shorts stories and novels. The course emphasized examining imagined future geographies (the presence or absence of certain areas and the depictions of urban life). Novels include: **Neuromancer** by William Gibson; **He, She, and It** by Marge Piercy; **The Postman** by David Brin; and **Pacific Edge** by Kim Stanley Robinson.

Understanding Rhetoric: Advanced Composition

Fall 1997

This advanced writing course taught students how to produce and critique works according to the canons of classical rhetoric. In addition to examining the writing styles and research methodologies of their disciplines, students studied modes of persuasion through reviewing academic essays, print media, film, and television.

Introduction to College English

Fall 1996, Spring 1997

This course introduced students to principles of effective writing by studying the canons of classical rhetoric. Students studied modes of persuasion used in academic essays, print media, film, and television.

Ireland Study Tour

Graduate Teaching Assistant, Summer 1998, Summer 1997

Coordinated the series of guest lecturers that provided study abroad students with a foundation for examining the politics and culture of Ireland. Organized tours of political and cultural destinations that reinforced the lecture material.
